### 2.3.1 Teaching- Learning Process:

MAMCP seeks out novel teaching strategies to enhance students' capacity for learning by implementing student-centered approaches like experiential learning, participatory learning, and problem-solving procedures. Teachers and students participate equally in the learning process in a student-centered teaching paradigm.

#### **Experiential learning:**

Faculty members engage students in direct experience and focused reflection on a regular basis in order to increase knowledge, develop skills, and clarify their doubts. Incorporate rich experiential teaching methods such as experimentation, demonstration, group projects, online learning, webinars, video lectures, visual aids, industrial visits, organizing exhibitions, and skill-development programmes to create a positive learning environment.

**Participative Learning:** Students participate in learning activities like – Group Discussions, Small Group Exercises, Assignments, Elocution, Quiz, Case Study, Projects etc.,

**Assignments:** Assignment topics are given to students in order to enhance their learning and language abilities.

**Seminars/Workshops/Conferences:** We encourage the Students to Participate in Campus or outside the campus Seminars/Workshops/Conferences. These Seminars, workshops and conferences hold great importance of life of a student. They are platforms not only to learn new aspects, others perspectives and latest information, but also a good way of networking.

**Group discussions:** Group discussions are held to help students create conceptual frameworks, learn how to solve problems, and share their own thoughts on the concepts.

**Journal Club:** Students and faculty gather to discuss published articles, providing a forum for a collective effort to keep up with the current literature.

**Internship :** Students during final year/immediately after completion of all courses, are allowed to perform an year/1 month internship in an approved hospital/

industry/ research laboratory/ drug testing laboratory. By this Internships students Develops Expand their clinical knowledge and skill set, Develop their confidence and resourcefulness, Build their personal and professional network, Sharpen the verbal and non-verbal communication.

**Hospital posting/Clerkship:** Hospital posting. Every student shall be posted in constituent hospital for a period of not less than fifty hours to be covered in not less than 200 working days in each of second, third & fourth year course. Each student shall submit report duly certified by the preceptor and duly attested by the Head of the Department or Institution as prescribed. In the fifth year, every student shall spend half a day in the morning hours attending ward rounds on daily basis as a part of clerkship. They help to the students to develop clinical exposure and medicine experts in the field of Pharmacy.

**Project work:** Students during V<sup>th</sup> Pharm.D, final semester(s) (B.Pharmacy and M.Pharmacy) undergo project work for 6 months to 1 year to buildup team work and group skills.

**Practice school:** Practice school course is offered during seventh semester of undergraduate program for a period of 150 hours. It also helps to enable students to acquire learning by applying the knowledge and skills they possess, in unfamiliar, open-ended real life situations and also the practice school will provide excellent in skill to put in the students main core.

**Learning through extension activities:** Students participate in extension activities like tree plantation, blood donation, swachh bharat , health awareness programmes, Road safety awareness Programmes etc., under the NSS.
